WATER ISAC

**Maintained** information-sharing relationships with federal and state partners:

- Cybersecurity and Infrastructure Security Agency (CISA)
- · DHS Intelligence & Analysis (DHS I&A)
- Environmental Protection Agency (EPA)
- Federal Bureau of Investigation (FBI)
- · Law enforcement/intelligence fusion centers
- State homeland security and emergency management agencies

Advised federal agencies on key threat alerts.

**Provided** members with over 1,000 advisories that warned of utility threats and vulnerabilities. Mitigation best practices by security analysts were added to advisories to help utilities reduce their risks.

**Collected** dozens of member-shared incident reports identifying dozens of water and wastewater cyber attacks and physical incidents. The reports are anonymized and shared in our *Quarterly Water Sector Incident Summaries* to make utilities aware of the threat environment.

**Conducted** ongoing Supply Chain Disruptions Surveys, which have identified challenges for utilities in obtaining treatment chemicals, parts, electronics, constructions materials and more. Survey results are shared back with members and federal partners for mutual awareness and planning.

**Coordinated** on security challenges with dependent and interdependent critical infrastructure sectors through involvement in the National Council of ISACs and partnerships with other ISACs.
